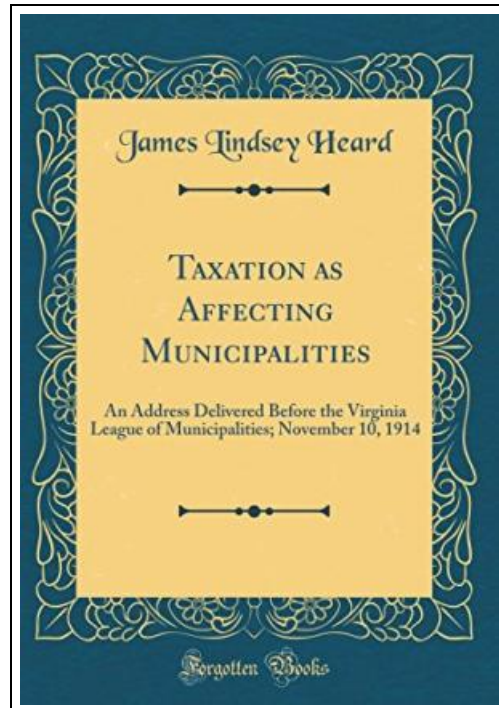

As between the Federal and State governments it has long been in vogue. For many years the Federal government has derived a considerable part of her revenues by taxing wines, liquors and tobacco, and has left unto the States and their sub-divisions the sole right to tax lands and most other tangible property, real and personal. The Federal government has long exercised the exclusive right to impose customs duties, and to use the revenue derived therefrom for her own purposes. For a long time she left to the States the taxing of incomes, but has recently, in a statute of far-reaching consequences, entered that field along with the several States. A number of the States of the Union have adopted the segregation plan of taxation, in various forms, as between themselves and their cities and counties. The underlying principle is not entirely new as between the State of Virginia and her cities and counties. For a number of years the State has appropriated to itself all franchise taxes, all charter fees, etc. The taxes on most other kinds of property, she has hitherto divided between herself and the respective local subdivision in which it was taxable. On real estate, for example, the State has taken, out of the aggregate tax paid by the owner, thirty-five cents on each one hundred dollars of assessed valuation, leaving the rest of the taxes on that particular property to the local community. The legislature of 1914, directly pursuant to the above - mentioned constitutional provision, enacted that all money...
