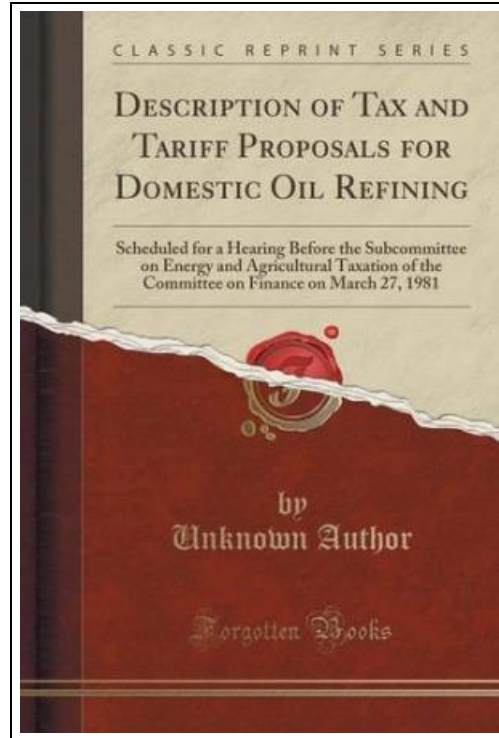

The hearing is on various proposals for tax incentives and tariffs to aid the domestic crude oil refining industry. Four specific proposals are among those to be addressed by the hearing. As announced in the Subcommittee s press release (81-113) March 11, 1981, these relate to (1) a modification of the foreign tax credit rules, (2) a tariff or fee on the importation of foreign refined petroleum products, (3) tax credits and accelerated depreciation for upgrading or retrofitting domestic refineries, and (4) the creation of tax-exempt crude oil purchasing cooperatives. The second part is an overview of the oil refining industry, and the third part is a summary of the government regulations that have affected the oil refining industry.
